ARTICLE I - TITLE

The name of this organization shall be the Woman's Auxiliary of the United States Section of the International College of Surgeons.

ARTICLE II - OBJECTS

The objects of this organization are:

1. To assist the United States Section of the International College of Surgeons and its parent body in achieving its stated purposes.
2. To render individually and collectively such other services as may be requested by their authorized governing bodies.
3. To extend the aims of the United States Section of the International College of Surgeons and the parent body.
4. Aid in the promotion of surgical education, postgraduate training, scientific research and philanthropic endeavor.
5. Aid in international good will.

ARTICLE III - MEMBERSHIP

Section 1:

Membership in this Auxiliary shall be composed of Active, Honorary and Life Members.

A. Active Members shall be spouse/partner, widow, widower, children or parents of an active member of the United States Section of the International College of Surgeons or an individual who was an active member at the time of death.

B. Honorary Members: Honorary membership may be bestowed upon individuals for achievements or distinguished service to the Auxiliary or to the International College of Surgeons upon recommendation of the Board of Directors of the Auxiliary and the approval of the Executive Council of the United States Section of the International College of Surgeons.

Section 1: (continued)

C. Life members shall be spouse/partner, widow, widower, children or parents of an active member of the United States Section of the International College of Surgeons or an individual who was an active member at the time of death. in good standing of the United States Section of the International College of Surgeons who, in lieu of payment of annual dues, shall make a single payment of \$200.00 and shall be considered active members.

Section 2: Voting Privilege

A. Active members shall be entitled to one (1) vote on each matter submitted to a vote of the members.

B. Honorary members shall be entitled to all the rights and privileges of the Auxiliary, other than election to office or to vote.

Section 3: Vacating Membership

Resignation, Suspension, Expulsion. Resignation of members shall be in writing, addressed to the Board of Directors of the Auxiliary. Membership in the Auxiliary may be terminated at any regular meeting or duly called special meeting of the Board of Directors, by two-thirds affirmative vote, with the approval of the Executive Council of the United States Section of the International College of Surgeons, if in the opinion of the Board of Directors, the conduct of any member is incompatible to the welfare of the organization. If termination of membership is for non-payment of dues, then notice of such delinquency may be given, and if delinquency not paid in full within 21 days of mailing such notice, then the membership shall automatically stand as terminated.

If termination of membership is for any other reason, then notice of proposed termination shall be given to such member, setting forth therein the specific charges. Such member shall be given said notice not less than 45 days prior to the meeting of the Board of Directors of this Woman's Auxiliary at which proposed action is to be taken, and she shall respond in writing, answering said charge, not less than 15 days prior to said meeting. At such meeting of the Board, the accused member shall have the right to appear before the said Board, with legal counsel of her own selection, and evidence may be taken, witnesses heard and cross-examined, and argument heard pertaining to such charge or charges.

If the accused member does not file an answer to such charge and does not appear at the stated hearing, the charges shall be taken as confessed. If after the hearing at the date, time and place specified, the Board finds the member guilty as charged, the Board may reprimand such member, suspend them from membership, or office, for a stipulated period of time, or terminate them from membership. A copy of the order of the Board shall be sent to such individual within ten days of the ruling by the Secretary. The accused shall have the right of appeal to the Executive Council of the United States Section within 30 days of the issuance of the ruling by the Board. Due notice shall be given to said appellant of the date, time and place of the hearing of the appeal, which may be before the full Executive Council of the United States Section of the Executive Committee or the Executive Council of the United States Section. The appellant shall have the right to be represented by counsel on such appeal. The appellate review shall be limited to issues of law and fact raised on the original

complaint, and answer, if any, written arguments or briefs. The decision of the Executive Council of the United States Section shall be final.

Section 3: Vacating Membership (continued)

All notices to be given shall be either by personal service or by delivery by mail and deposit in the United States Mail by registered mail, postage prepaid, and if to the accused member, shall be addressed to her at her address as it appears on the rolls of membership of the Auxiliary, and which shall constitute service of notice. Notice to the Auxiliary shall be sent to the President at 1516 North Lake Shore Drive, Chicago, Illinois 60610 with a copy to the Secretary.

ARTICLE IV - DUES

Section 1:

A member shall be considered in good standing in the Auxiliary of the United States Section of the International College of Surgeons and eligible to be a Director only following payment of dues hereinafter described in Section 2.

Section 2:

- A. Membership dues of active members shall be the sum of \$30.00 annually, effective January 1, 1990.
- B. Honorary members shall pay no dues.
- C. Life members shall make a single payment of \$200.00.

Section 3:

The fiscal year shall begin January 1. Members shall not be considered for Board membership if their dues are not current by March 1.

Section 4:

Dues money is to be used for the Museum of Surgical Sciences and the Scholarship Program of the United States Section of the International College of Surgeons and the Continuing Medical Education Program after administrative expenses of the Auxiliary are met.

ARTICLE V - BOARD OF DIRECTORS

Section 1:

The activities and business of the Woman's Auxiliary shall be under the management and control of the Board of Directors, subject to the approval of the Executive Council of the United States Section of the International College of Surgeons.

Original Language

Section 2:

The number of Directors shall no be less than nine (9) nor more than twenty-five (25). Past presidents appointed to specific positions of the Board of Directors shall be counted within these limits.

Proposed New Language

Section 2:

The number of Directors shall not be less than five (5) nor more than twenty-five (25). Past presidents appointed to specific positions of the Board of Directors shall be counted within these limits.

Section 3:

Term of office shall be one (1) year.

Section 4:

A. The Board of Directors of the Woman's Auxiliary shall consist of the general officers enumerated in Article VII,

Section 1, the selected directors, and all past presidents so stipulated in Section 2. The immediate past president shall serve as an active member for one (1) term following their tenure of office.

B. All past presidents shall serve in an honorary advisory capacity and without vote, unless appointed as an active member of the board.

Section 5:

The board of Directors shall carry out the aims and policies of the Auxiliary, subject to (1) provisions of these by-laws, and (2) instructions from the Executive Council of the United States Section of the International College of Surgeons.

Section 6:

Five (5) members of the Board of Directors shall constitute a quorum.

Section 7:

The following shall be the order of business of the Board of Directors unless otherwise ordered:

1. Call to order by the presiding officer
2. Roll Call
3. Appointment of Reading Committee
4. Reports of Officers
5. Reports of Committees
6. Communications
7. Unfinished Business
8. New Business
9. Adjournment

Section 8:

The Board of Directors shall be governed by ROBERT'S RULES OF ORDER REVISED, when not in conflict with these By-Laws.

ARTICLE VI - MEETINGS

Section 1:

Meetings of the Membership. A regular meeting of the membership of the Woman's Auxiliary of the United States Section of the International College of Surgeons shall be held at the same place with the designated time and place of the Annual Meeting of the House of Delegates and of the Executive Council of the United States Section of the International College of Surgeons. Special meetings of the membership of the Woman's Auxiliary may be called by action of the Board of Directors upon thirty (30) days written notice.

Section 2:

Meetings of the Board of Directors. The regular annual meeting of the Board of Directors of the Woman's Auxiliary shall coincide with the Annual Meeting of the House of Delegates and the Executive Council of the United States Section. One (1) additional meeting of the Board of Directors shall be held each year at a time and place to be designated by action of the Executive Committee of the Board of Directors. Special meetings of the Board of Directors of the Woman's Auxiliary may be called by the President with the approval of the Executive Committee and at such time and place as may be designated by them.

Meetings of the Executive Committee. Meetings of the Executive Committee of the ICS US Alliance (Women's Auxiliary) will be prior to or in conjunction with the Annual Board of Director's Meeting of the Alliance (Women's Auxiliary) and shall be held at the same time as the Executive Committee of the ICS-US Section during its annual meeting. Special meetings may be called as required by the President.

Section 3:

Notice. Notice of such meetings shall be given in writing to the membership and to the Board of Directors not less than thirty (30) days prior to the respective meetings. These shall be mailed by the Secretary to the members thereof at the addresses of such members indicated on the roll of membership, not less than thirty (30) days prior to the date of such meetings. (See Article IX, Section 7B)

Section 4:

Attendance:

A. A member of the Board of Directors is expected to attend the regular meetings during their term as Director or officer.

B. Committee Chairmen are to submit written reports if they are unable to attend.

ARTICLE VII - OFFICERS

Original Language

Section 1:

The general officers of the Auxiliary shall be President, President-Elect, First Vice President, who shall be Membership Chairman, Second Vice President, who shall be Assembly Chairman, Secretary, and Treasurer.

Proposed New Language

Section 1:

The general officers of the Auxiliary shall be President, President-Elect, ~~First Vice President, who shall be Membership Chairman, Second Vice President, who shall be Assembly Chairman,~~ Secretary, and Treasurer.

The President-Elect is hereby designated to automatically become President for the year next succeeding their election to the office of President-Elect, and in the event of the resignation, refusal or inability of the President to serve, the President-Elect shall fill such vacancy.

Section 2:

The nominating Committee selected in accordance with Article VIII hereof shall meet upon the call of its Chairman and shall have the responsibility and the duty of formulating a list of nominees of one or more members of the Woman's Auxiliary for each of the offices to be filled at the ensuing annual meeting of the Board of Directors, which annual meeting shall be held in conjunction with and at the same place as the meeting of the United States Section

Executive Council and House Delegates. At said annual meeting of the Board of Directors, the

Nominating Committee shall present such names in nomination for the respective offices.

Section 2: Continued

Nomination for office may also be made from the floor at the meeting of the Board of Directors by any member of the Board of Directors. In the event no nominee receives a majority of the votes on the first ballot, the name receiving the lowest number of votes shall be dropped and a new ballot shall be taken; and this procedure shall be followed until a nominee for each office is elected by a majority of the votes cast by members of the Board of Directors. The officers so elected by the Board of Directors shall be subject to the approval of the Board, and such officers shall be installed at the final meeting of the fiscal year. The nominee must have been a member of the Board of Directors for at least one term, and shall be the spouse, widow, widower, children or parents of an active member of the United States Section of the International College of Surgeons or an individual who was an active member at the time of death.

Section 3:

There shall be a Parliamentarian appointed by the President. She shall attend all meetings and advise, when requested, the President, the Board of Directors, Executive Committee and any committee, officer, or member on Parliamentary questions concerning the Auxiliary.

Section 4:

The appointed officers and directors shall serve for one (1) year to run concurrently with the term of officers of the United States Section of the International College of Surgeons or until qualification and appointment of their successors.

ARTICLE VIII - NOMINATING

Section 1:

The Nominating Committee shall consist of five (5) members and shall be formed at the first business meeting of the fiscal year.

One (1) member shall be appointed by the President, one (1) member shall be appointed by the President-Elect from the Board, and two (2) shall be elected from among the members of the Board by the Board. The President-Elect shall serve on the Nominating Committee. No member shall serve on the Nominating Committee who has not served on the Board of Directors for at least one (1) year.

No member of the Nominating Committee shall serve for two (2) consecutive terms. The nominating Committee shall elect its own Chairman.

Section 2:

A. In the absence or inability of the President to serve, the President-Elect shall fill the duration of the term.

Section 2 A. Continued

Original Language

In the absence of the President-Elect, the First Vice President, then the Vice Presidents in their consecutive numerical order, shall fill the temporary vacancy.

Proposed New Language

In the absence of the President-Elect, the Treasurer, then the Secretary, shall fill the temporary vacancy.

B. If any office provided for in Section 1 of Article VII shall become vacant before expiration of term, the Executive Committee shall appoint an active qualified member of the Board of Directors of the Auxiliary to serve the unexpired portion of the term, subject to the approval of the Executive Council of the United States Section of the International College of Surgeons.

C. Vacancies in the office of the Chairmen for any committee appointed by the President or Board of Directors shall be filled by the appointing person or Board.

ARTICLE IX - GENERAL OFFICERS

Section 1:

The duties of the officers shall be such as are implied from their respective titles and such as are specified in the By-Laws.

Section 2: The President shall:

A. Be the presiding officer of the Board of Directors and of the Executive Committee and of the General Assembly.

Section 2:

B. Be a member ex-officio of all committees with the exception of the Nominating Committee.

C. Subject to confirmation of the Executive Committee, appoint special committees as she may deem necessary, provided, however, that no special committee shall be appointed to assume any of the duties of any standing committees.

D. Serve on the Board of Directors as an active member for a period of one term, following expiration of her tenure of office.

E. Co-sign all orders of the Treasurer for disbursement of funds as directed by the Board of Directors of the Executive Committee. The Financial Manager/CFO of the United States Section shall sign in absentia of the President.

F. Endeavor to impart to the President-Elect any information pertinent to the objectives and guidance of the projects of the organization, in order to propagate a smooth functioning of the Auxiliary.

G. Appoint one (1) member of the Nominating Committee.

H. With the approval of the Executive Committee, designate a past president as the Chairman or member of at least one committee. When so appointed, such past president assumes the rights and privileges of an active member of the Board of Directors for the period of the appointment.

I. Appoint, subject to confirmation by the Executive Committee, the chairmen of all standing committees except where these By-Laws provide to the contrary.

J. Appoint a Parliamentarian.

Section 3: The President-Elect shall:

A. Be active aid to the President any by membership on the Board of Directors during her term of office, familiarize herself with the duties of President and with the affairs and personnel of the Auxiliary to enable her to fulfill efficiently the office of President when she succeeds thereto.

B. Serve on the Nominating Committee.

C. Appoint one (1) member from the Board of Directors to serve on the Nominating Committee.

D. Fill the vacancy in case the President is unable to serve. (See Article VIII, Section 2A)

E. The President-Elect shall act as co-signer in the absence of the Treasurer.

~~Section 4: The First Vice President shall:~~

~~A. Be the Membership Chairman and have such posers and perform such duties as may be delegated to her by the Board of Directors.~~

~~B. In the absence or inability to serve of the President and President Elect, fill the temporary vacancy.~~

~~Section 5: The Second Vice President shall:~~

~~A. Be Assembly Chairman and shall have such powers and perform such duties as may be delegated to her by the Board of Directors.~~

~~B. Fill a vacancy created by the officers designated above.~~

~~Section 6: The Third Vice President shall:~~

~~A. Be Hospitality chairman and have such powers and perform such duties as may be delegated to her by the Board of Directors.~~

Section 7: The Secretary shall:

- A. Keep in permanent form a correct record of the proceedings of all the meetings of the Board of Directors, the Executive Committee and the Annual Assembly. Copies of the minutes to all meetings shall be mailed, within two (2) weeks after the meeting, to the Reading Committee composed of the Secretary and two (2) readers appointed by President at the beginning of each meeting. These are to be read, any corrections noted and returned to the Secretary within two (2) weeks. Copies of corrected minutes shall be sent to the Executive Committee of the Board of Directors and to the Board with the meeting notices of the following meeting.
- B. Keep an accurate list of the names and addresses of all members of the Board of Directors including Honorary Members and Past Presidents, and of all committees and notify committee members of appointment.
- C. Assist the President in preparing agenda for the Board meetings, if requested.
- D. Be custodian of all records, books, the Auxiliary Seal and the Bond of Treasurer.
- E. Preserve in a permanent file, all records and correspondence of value to the Organization and its officers to be transferred to her successor at the close of her term.
- F. Send copies of the minutes to the Executive Council of the United States Section of the International College of Surgeons, if requested.
- G. In the case of her inability to attend a meeting, prepare copies of the minutes of the previous meeting in duplicate and mail by certified mail to the President of the Auxiliary, and to the President-Elect.
- H. Conduct the Correspondence of the Auxiliary.
- I. Send official notices to Board Members in accordance with provision for same in the By-Laws at least thirty (30) days in advance of the Board Meeting. (See Article VI, Section 3)
- J. Keep and transfer records to her successor at the close of her term of office, including files or reports such as correspondence and Board Membership lists and copy of the By-Laws.

Section 8: The Treasurer shall:

- A. Be the custodian of the funds of the Auxiliary.
- B. Deposit all funds in a depository approved by the Board of Directors.
- C. Keep an itemized account of all receipts as provided by the comptroller.
- D. Co-Sign checks with the President, upon authorization of the President. The Financial Manager CFO of the United States Section shall sign in absentia of the Treasurer.

Section 8: The Treasurer shall: (Continued)

- E. Tender a statement of her current account and make an annual written report to the Executive Council of the United States Section of the International College of Surgeons.
- F. Upon request, exhibit books and accounts to any member of the Board or to the Executive Council of the United States Section of the International College of Surgeons.
- G. Perform all acts and duties of her office, subject to the control of the Board of Directors.
- H. All accounts shall be audited annually by the C.P.A. designated by the Executive Council of the United States Section of the International College of Surgeons.
- I. Allocate funds for purchase of commemorative gift for presentation to outgoing President.
- J. The President-Elect shall act as the co-signer in the absence of the Treasurer.

ARTICLE X - EXECUTIVE COMMITTEE

Original Language
Section 1:

The Executive Committee shall consist of eight (8) members, namely the President, President-Elect, Immediate Past President, First Vice President (Membership Chairman), Second Vice President (Assembly Chairman), Third Vice President (Hospitality), Secretary, and the Treasurer. The President shall be the presiding officer of the Executive Committee.

Proposed New Language
Section 1:

The Executive Committee shall consist of five (5) members, namely the President, President-Elect, Immediate Past President, Secretary, and the Treasurer. The President shall be the presiding officer of the Executive Committee.

Section 2:

The Executive Committee shall perform the duties of the Board of Directors and transact all business of the Auxiliary between meetings of the Board of Directors.

Section 3:

The Executive Committee shall be subject to call, by the President, for any specific reason, upon ten (10) days written notice.

Section 4:

The Executive Committee shall present a written report to the Board at the first meeting of the Board following action of the Committee.

Section 5:

Three (3) members of the Executive Committee shall constitute a quorum.

ARTICLE XI - COMMITTEES

Section 1: Designations - The Committees of the Auxiliary shall be:

- A. Standing Committees directly responsible to the Board of Directors.
- B. Special Committees which may be created by the President with the approval of the Board of Directors.

Section 2: Standing Committees

Archives and History, Assembly, "Newsletter", the By-Laws, Scholarship, (International Auxiliaries), Museum of Surgical Sciences, (Liaison), Membership, Tribute, and Nominating. The Chairmen of these Standing Committees shall be appointed by the President, except as otherwise specified herein.

Section 3:

The Chairman, or some member designated by her, of each of these committees shall submit an annual written report of its activities. Copies of these reports shall be submitted to the Executive Council of the United States Section of the International College of Surgeons.

ARTICLE XII - DUTIES OF STANDING COMMITTEES

Section 1:

The committee on Archives and History shall compile a permanent history of this organization, including the Annual Meeting, collect material for archives, and be informed on both Archives and History of the Auxiliary.

Original Language

Section 2:

The Committee on Assembly shall consist of the Second Vice President who will be Chairman, who is appointed by the President, and as many members as necessary. The Chairman shall assist the President in planning the program for the annual meetings and serve as liaison between the host committee and the Board of Directors.

Proposed New Language

Section 2:

The Committee on Assembly shall consist of a Chairman, who is appointed by the President, and as many members as necessary. The Chairman shall assist the President in planning the program for the annual meetings and serve as liaison between the host committee and the Board of Directors.

Section 3.

The Newsletter Committee shall consist of a Chairman appointed by the President, and such other members as may be judged by the President as necessary, who will assist the President in arranging for contributions to the Auxiliary Section of the U.S. News and Notes.

Section 4:

The Committee on By-Laws shall consist of a Chairman appointed by the President and two (2) others appointed by the Chairman. It shall be the duty of this committee to receive and study all suggestions and proposed amendments to the By-Laws, to present them to the Board of Directors for consideration, and to the Executive Council of the United States Section of the International College of Surgeons for final action.

Section 5:

The Committee on Scholarship shall consist of a Chairman, appointed by the President, and such other members as may be deemed necessary. The Chairman shall serve as a liaison to the Scholarship Committee of the International College of Surgeons, United States Section. The purpose of this committee is to acknowledge financial awards to students of medicine who are chosen by the United States Section of the International College of Surgeons to participate in the scholarship program. The Chairman shall keep on file information and important details of each recipient and make a periodic report to the Board of Directors.

Section 6:

The Committee on the International Museum of Surgical Sciences shall consist of a Chairman, preferably from the Chicago area, and other appointees of this chairman. The committee shall perform such duties connected with the International Museum of Surgical Sciences as shall be requested by the Executive Council of the United States Section or by the International Board of Governors of the International College of Surgeons.

Original Language

Section 7:

The Committee on Membership shall consist of a Chairman who shall be First Vice President. She and her committee shall strive to increase membership and shall develop and supervise this Auxiliary program, and assist in collection of dues.

Proposed New Language

Section 7:

The Committee on Membership shall consist of a Chairman. The Chair and committee shall strive to increase membership and shall develop and supervise this Auxiliary program, and assist in collection of dues.

Section 8:

The Tribute Committee shall consist of a Chairman and such other members as are judged necessary. The duties of this Committee shall be to stimulate tribute contributions. Specific procedure for the Chairman has been worked out and proven most successful, and shall be as follows:

A. Upon receipt of a gift in any amount, a note acknowledging the gift and naming the donor shall be sent to the family of the deceased who are also informed for what purpose these gifts are to be used.

B. A note of thanks shall be sent to the donor and both names are entered in the permanent "In Memoriam" book located in the Hall of Fame at the International College of Surgeons headquarters in Chicago.

C. Notes of sympathy are sent to families of deceased when the Chairman is apprised of their loss.

Section 9:

The Nominating Committee shall consist of a Chairman chosen by the elected committee from the five (5) members. (See Article VII, Section 2, and Article VIII on Nominating)

ARTICLE XIII - POLICY

Section 1:

This Auxiliary shall not affiliate with other federated organizations, nor provide for representation on its Board of Directors of representatives of other organizations, nor be itself officially represented on the Board of other organizations without the approval of the Executive Council of the United States Section.

Section 2:

No commercial interest nor any candidate for public office shall be endorsed by the Auxiliary. Neither the name of the Auxiliary nor the name of any officer in her official capacity shall be used in any connection with a commercial concern or with any political interest, or in the support or defeat of any legislation.

ARTICLE XIV - EFFECTIVE DATE

The By-Laws shall be effective immediately upon adoption by the Board of Directors of the Auxiliary of the International College of Surgeons United States Section, upon approval by the Executive Council of the United States Section of the International College of Surgeons, provided however, that the officers and chairmen of Standing Committees and members of the Board of Directors shall continue in office until their expiration of term of office in January.

ARTICLE XV - AMENDMENTS

Section 1:

The By-Laws of this Auxiliary may be amended by the Board of Directors by an affirmative vote of not less than 2/3 of the members of the Board of Directors present in person at any duly convened meeting provided that the proposed amendment has been submitted in writing, mailed to each member of the Board of Directors at least thirty (30) days prior to the date upon which the proposed amendment is to be presented, PROVIDED HOWEVER, that no such amendment so adopted shall become valid and effective until first submitted to and approved by the Executive Council of the United States Section of the International College of Surgeons.

Section 2:

Proxy voting shall not be permitted.

ARTICLE XVI - DISSOLUTION AND LIQUIDATION

In the event of the dissolution and liquidation of the Woman's Auxiliary of the United States Section of the International College of Surgeons and prior to the completion thereof, all of the assets, property, income and all other funds of the Woman's Auxiliary of the United States Section of the International College of Surgeons now owned or held upon a condition requiring return, transfer or conveyance by reason of dissolution, shall be expended for or applied to the purposes of the Woman's Auxiliary of the United States Section of the International College of Surgeons, as set forth in the Articles of Incorporation of the Woman's Auxiliary of the United States Section of the International College of Surgeons, or one or more of such purposes, by transferring and conveying such assets, property, income and funds to one or more corporations or organizations, organized and operated exclusively for charitable, scientific, literary, or educational purposes, to which exemption from income taxes has been granted under Section 501 (c) (3) of the Internal Revenue Code of 1954, or comparable provisions of the prior or subsequent Federal Income Tax Laws, and no part of such remaining assets, property, income or funds shall be distributed to members or to any other person whatsoever.

ARTICLE XVII - HEADQUARTERS

The Headquarters of the Woman's Auxiliary of the International College of Surgeons, United States Section, shall be maintained at the
