Dr. Andrew Klein is the Esther and Mark Schulman Chair in Surgery and Transplant Medicine, Vice Chairman of the Department of Surgery and Director of Comprehensive Transplant Center at Cedars-Sinai Medical Center in Los Angeles, California. He received his undergraduate degree from Duke University and his M.D. and M.B.A. degrees from Johns Hopkins University. He completed residency training at The Johns Hopkins Hospital, was a Harvard research fellow in transplantation immunology at The Massachusetts General Hospital, served as a Surgical Registrar at The John Radcliffe Hospital, Oxford University and was a liver transplant fellow at UCLA.

Dr. Klein was appointed Professor of Surgery at The Johns Hopkins University School of Medicine in 2000, at UCLA in 2005 and at Cedars-Sinai in 2008. His accomplishments in the fields of both medicine and business were recognized by Johns Hopkins, who bestowed upon him the Distinguished Alumnus Award. His scientific research has been supported by institutional, intramural (NIH), and industry funding. In 1991 he received the Johns Hopkins Clinician Scientist Award. Dr. Klein has authored or co-authored more than 150 original manuscripts and 29 chapters and has lectured extensively in North America, Asia, and Europe. For nearly 3 decades, Dr. Klein has played a leadership role in local and national policy making focused on organ donation, allocation, and transplantation.

In 2002, Dr. Klein received his M.B.A. from Johns Hopkins University and in recognition of his outstanding performance he was honored with the Student of the Year Award. He has a keen interest in the relationship between civility and tangible benefits in healthcare. He has championed the value of service excellence and civil culture in the workplace, the selection and training of employees, and the consequences of uncivil behavior on coworkers and patients.

Dr. Klein and his wife, Julia, are avid SCUBA divers which allows Dr. Klein to pursue his passion for underwater photography. When work permits, they are likely to be found hanging out with their cows, sheep and chickens on their farm in Pennsylvania.

ROBERT L. WALTON, MD RECIPIENT OF THE DR. ANDRE CROTTI AWARD FOR DISTINGUISHED SERVICE TO THE PROFESSION OF SURGERY AND INTERNATIONAL COLLEGE OF SURGEONS HONORARY FELLOWSHIP

Dr. Walton's career includes numerous outstanding academic achievements and cutting edge contributions in the field of research. All the while, he has never forgotten the small town values of the community in which he was raised. After completing his undergraduate studies and medical training at the University of Kansas, he served a surgical internship and residency at the Johns Hopkins Hospital in Baltimore. For his outstanding performance he was named a Halsted Fellow both years. Dr. Walton then went on to Yale University where he completed his general surgery residency and plastic and reconstructive surgery fellowship. Long before "global surgery" came into vogue, Dr. Walton traveled to Haiti in 1976 during his residency to volunteer his time and talents. Since that time, and over the past 41 years he has traveled at least annually and of late, multiple times during any one given year to drive his private foundation Proyecto Miro, which was established in 1992, to provide gratis plastic and reconstructive services to the poor served by the San Jorge Children's Hospital in Santurce, Puerto Rico.

These volunteer credentials are all in the shadow of the major leadership roles he has held in medicine and the personal impact of his mentorship on training young surgeons. After completing his training at Yale, Dr. Walton became the Chief of Plastic and Reconstructive Surgery and Co-Director of the Burn Unit at the University of California in San Francisco Hospital. During this time, he began the first of his over three hundred invited lectures that he has delivered, and fifty-four book chapters he has written during his career. After spending four years at UCSF, he accepted the position of Chair of the Division of Plastic and Reconstructive Surgery at the University of Massachusetts Medical Center in Worcester, MA, being appointed Professor of Surgery shortly after his arrival. His focus on trainees has inspired many general surgery residents to choose plastic surgery as their life's opus. What makes Dr. Walton truly a great surgical educator however is his enthusiasm for not only his specialty, but his ability to share that energy with the trainees under his tutelage. Many of those trainees are now Division/Department Chairs and Training Program Directors in their own right.

After a decade in Worcester, Dr. Walton accepted the position of Section Chief of Plastic and Reconstructive Surgery at the University of Chicago Hospitals and Clinics. Along with his clinical and education duties he took major leadership roles in his specialty, some of these roles included: President - New England Society of Plastic & Reconstructive Surgeons, Director - American Association for Hand Surgery, Senior Examiner - American Board of Plastic Surgery, President - Chicago Society of Plastic Surgeons, President - American Society for Reconstructive Microsurgery, and Board Member of the American Society of Plastic Surgeons. This period of time enabled him to continue an already prolific research career with a multitude of original contributions to the literature in the most prestigious plastic surgery journals.

Following a decade at the University of Chicago Dr. Walton was named a Professor of Surgery at the Northwestern University School of Medicine in Chicago and became the Chief of Plastic Surgery at the Presence-St. Joseph Hospital. His persona and leadership of the Division have inspired almost half of the graduating Chief Residents over the past ten years to pursue fellowship training in plastic and reconstructive surgery.

Dr. Lakshmanan is a medical graduate from Madras University India. He is a 30+ year veteran of the Los Angeles County Coroner's Office, and was appointed as Chief Medical Examiner-Coroner for Los Angeles County on February 18 1992 by the Board of Supervisors. The Board of Supervisors of Los Angeles County on recommendation of the Chief executive officer also appointed him to the position of Director (Interim) on April 3, 2012 and also requested him to continue his duties as Chief Medical Examiner-Coroner. Dr.Lakshmanan retired on August 11, 2013.Dr.Lakshmanan was re-appointed by the Board of Supervisors on April 11th 2016 as Interim Chief Medical Examiner-Coroner for Los Angeles County through January 18th, 2017.

Dr. Lakshmanan as Professor of Medicine and Pathology at the Keck School of Medicine was requested to remain as a Consultant and Director of Operations to the Department of Medical Examiner-Coroner as a USC faculty on January 19th 2017 to maintain the continuity of Department of Medical Examiner-Coroner operations.

He is a Board Certified Physician in several specialties including Anatomic, Clinical & Forensic Pathology, Internal Medicine, Geriatric Medicine and Infectious Diseases. He is also certified in pathology by the Royal College of Physicians and Surgeons of Canada. As a peace officer, he holds a specialized law enforcement executive certificate from the Commission on Peace Officers Standards and Training, State of California. Dr. Lakshmanan is a Professor of Pathology at Geffen School of Medicine UCLA (Voluntary) and has numerous publications to his credit.

The Department of Coroner handles one third of the deaths in Los Angeles County with a staff that includes forensic pathologists, investigators, criminalists, toxicologists and various other support staff. During his career at the Department of Coroner, Dr. Lakshmanan has responded to several disasters including the 1986 Cerritos air crash, 1991 LAX US Air crash, 1992 Los Angeles Riots, 1994 Northridge Earthquake, 2005 Glendale Metro-link multiple fatality train incident, 2008 Chatsworth Metro-link train accident and has personally handled/testified on several high profile cases. Moreover, while Dr. Lakshmanan was CME-C, the Department hosted the 39th Annual meeting of the National Association of Medical Examiners (NAME) in 2005 and published a textbook in Forensic Neuropathology in 2007. Of note, Dr. Lakshmanan was President of the NAME for calendar year 2010 and in 2011 he was Chairman of the Board of Directors for the same.

During his tenure as CME-C, Dr. Lakshmanan worked with organ procurement organizations (OPO) towards a zero denial policy by cooperating in the authorized removal and timely disposition of human organs and tissue from bodies of deceased persons, including victims of homicide, in accordance with law and accepted medical practice. The goal was to insure a balance between protecting the integrity of the Coroner's inquiry into an organ donor's cause and manner of death while increasing the supply of organs for potential recipients. This allowed for the OPO's timely procurement of organs which are medically viable and supported a "win-win" situation for the potential recipient and the Medical Examiner-Coroner's office by meeting the needs of the community as well as the criminal justice system.

#### VASCULAR SURGERY SYMPOSIUM

"Cirugia taurina" is the surgical discipline that treats lesions caused by bull horns. These lesions have distinct features and are observed both in matadores gored during bullfights in the ring as well as in runners injured during events that take place through streets of towns and cities in Europe and Latin America. Less frequently, they are also observed in other local festivities involving bulls.

The purpose of the featured presentation in this session is to provide a brief introduction about the "Fiesta de los Toros" (The Festivities of the Bulls), their different forms both inside and outside the rings. Dr. Leopoldo Fernandez Alonso from Spain will describe the minimal requirements needed to staff immediate response units in order to effectively treat these traumatic injuries that are often lifethreatening. 






# W Lake Shore Chicago Floor Plans
