
GREETINGS:

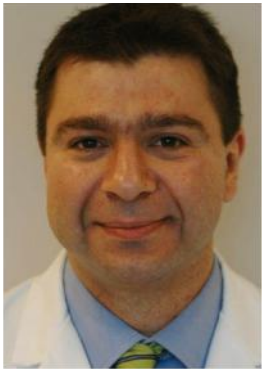

Demetrius E.M. Litwin, MD, Harry M. Haidak Distinguished Professor and Chairman, Department of Surgery at the University of Massachusetts Medical School, is an internationally recognized authority in the field of endoscopic, or minimally invasive surgery (MIS).

In 1997, Dr. Litwin joined the University of Massachusetts Medical School and UMass Memorial Medical Center as Associate Professor of Surgery, Director of Minimally Invasive Surgery Services, and as the first Director of the UMass EndoSurgery Center, a teaching and research resource in the field of minimally invasive surgery designed for developing new surgical devices and new procedures for minimally invasive techniques. Dr. Litwin was a key member of the UMass group that developed Handport™ a hand assist device for MIS. He has performed a number of “firsts” including minimally invasive operative approaches to the stomach and hand-assisted approaches to the aorta. Dr. Litwin has published numerous articles and book chapters highlighting laparoscopic surgery and has been a speaker at more than 200 proceedings worldwide. In 2004, Dr. Litwin was appointed the Harry M. Haidak Professor and Chairman of the Department of Surgery at the University of Massachusetts Medical School. Since then, he has doubled the size of the Department of Surgery, expanded the general surgery residency training program, and established two fully integrated training programs in Vascular Surgery and Plastic Surgery.

Before joining the University of Massachusetts Medical School, Dr. Litwin was Assistant Professor of Surgery and Director of minimal access surgery at the University of Toronto, Toronto, Ontario, Canada. He received his medical degree from the University of Saskatchewan in 1979 and obtained his surgical training at both the University of Saskatchewan and the University of Toronto where he completed a fellowship in Hepatobiliary Surgery. He obtained his certification as a Fellow of the Royal College of Physicians and Surgeons of Canada in 1986.

An early innovator and leader in surgical education, Dr. Litwin trained surgeons in safe minimally invasive techniques, and was recognized for his outstanding achievements in quality improvement by the Saskatchewan Medical Association and the College of Physicians and Surgeons of Saskatchewan. In 1992, he established one of the first fellowship training programs for minimally invasive surgery which continues to this day.

Dr. Litwin has been a member of the International College of Surgeons since 1986, transferring to the US Section in 1999. He served as Canadian Chapter President of the ICS in 1997. As an ICS member, Dr. Litwin has served in a variety of rolls including Vice President, Chair Board of Regents, Secretary and Treasurer.

Dr. Litwin continues to have an active practice in minimally invasive surgery, and he has developed a major interest in global surgery. He regularly participates in the University of Massachusetts Medical School Global Surgery initiatives in both Haiti and Honduras.

Dr. Lloyd E. Ratner, MD, MPH, FACS, will present the Dr. Andre Crotti Lecture. Dr. Ratner, is Professor of Surgery and Director of Renal and Pancreatic Transplantation at Columbia University. Prior to joining the faculty at Columbia, Dr. Ratner was on the faculty of Johns Hopkins University in Baltimore, and served as the Chief of Solid Organ Transplantation at Thomas Jefferson University in Philadelphia.

Access to organ transplantation has been Dr. Ratner's major academic interest. Dr. Ratner has been a leading innovator in transplantation for two decades. In 1993, he performed the world's first dual renal transplant. In 1995 (with Dr. Louis Kavoussi) he performed the first laparoscopic donor nephrectomy, and set the stage for its widespread adoption, which resulted in a profound increase in living donor kidney transplantation. Dr. Ratner has made significant contributions in overcoming immunologic incompatibilities that prohibited transplantation. He devised the plasmapheresis/IVIg protocol for alloantibody desensitization in 1998. In 2001, Dr. Ratner orchestrated the second paired-kidney exchange in the U.S. Subsequently, he arranged the first paired kidney exchanges in both Pennsylvania and New York. More recently Dr. Ratner has been a leading proponent of including compatible donor/recipient pairs in kidney exchanges. All of these strategies have increased organ availability and access to transplantation. Additionally, he has made important contributions to improve living donor safety. For his work, Dr. Ratner has received numerous awards and honors. And, he has been invited to speak and operate at various venues around the world.

Dr. Ratner has authored or co-authored over 180 peer-reviewed publications, and has been a federally funded investigator. His publications have been cited over 12,000 times. He served as the Chairman of the Board of Directors of the LiveOnNY (formerly the New York Organ Donor Network), and has served on numerous national committees including the Board of the United Network for Organ Sharing. He was elected Treasurer of the American Society of Transplant Surgeons, and presently serves as that Society's President-Elect.

Dr. Ratner originally hails from Brooklyn, NY. He received his undergraduate education at the State University of New York at Buffalo. He received his M.D. from Hahnemann University. His general surgery training was obtained at Long Island Jewish Medical Center. He completed a Fellowship in Transplantation Surgery and Immunology at Washington University. In 2011 Dr. Ratner completed a Master of Public Health with a focus on health care policy, administration and management.

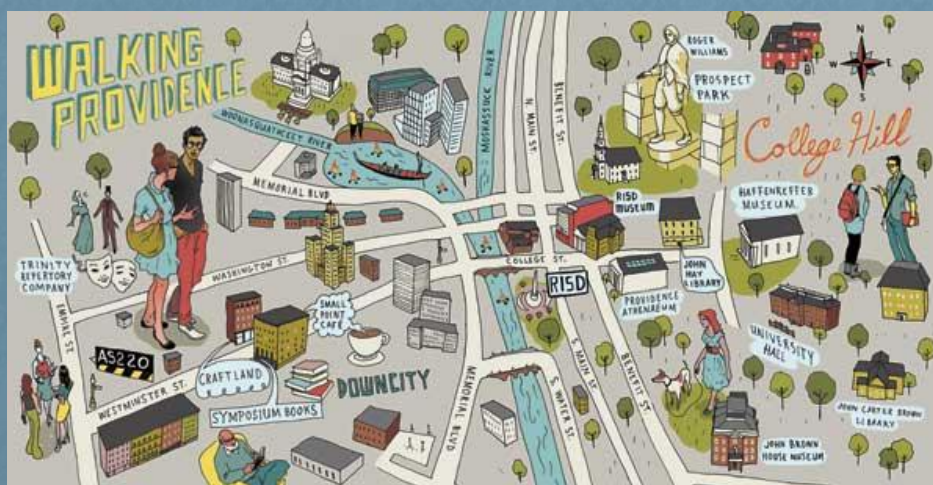
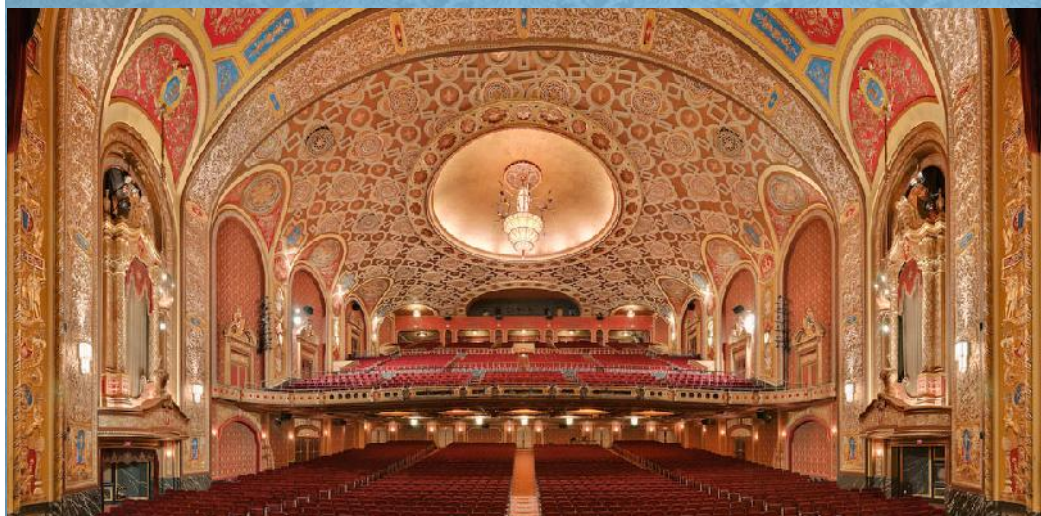
