Dixon Santana Aponte, MD is board certified surgeon in General and Vascular Surgery who has been in both academic and private practice since the beginning of his journey in the art of surgery and patient care. His main scope of practice is related to the complexity of major vascular issues and conditions affecting adult and pediatric patients. His evolution in this field has allowed him to use specialized, high technological instrumentation and devices combined with traditional long-standing surgical techniques to every patient he has an opportunity to serve and help with their disease processes.

Dr. Santana completed his doctoral degree in medicine at the University of Puerto Rico in San Juan where he also completed his general surgery post-doctoral training. He moved to Salt Lake City, Utah where he completed his fellowship in vascular surgery. He decided to bring his expertise and skills back to the University of Puerto Rico where he started the Vascular Surgery section and assumed the training and mentorship of most of the residents at the time. He also dwelled into private practice at nearby hospitals with the mission of improving the overall quality of vascular care at the time in the region. This became the foundation for further trainees to become vascular surgeons and continue offering up to date, state of the art care in the region.

He currently holds an academic ranking as a Professor in Surgery at Texas Tech University Health Sciences Center in Lubbock, Texas his practice site for the last 20 years. He serves the patients of West Texas and Eastern, New Mexico providing advanced vascular and endovascular care.

Dr. Santana has been a member of the International College of Surgeons since 2008. Global Surgical Care was one of the main reasons to join and collaborate with this fascinating organization since he had collaborated with missions to Dominican Republic and Nicaragua. Since then he has been involved in the organization in different roles, several of which have helped shape the current state of the US section.

Besides his surgical passion he enjoys spending time with his family; wife, son and two daughters. He enjoys outdoor activities, cycling, scuba diving, hiking and water sports being his favorite sports. He enjoys Afro-Caribbean and Latin jazz music.

INTERNATIONAL COLLEGE OF SURGEONS HONORARY FELLOW RECIPIENT

Michel Gagner, MD



Dr. Gagner is a highly-respected surgeon who is world renowned for his contributions to laparoscopic and bariatric surgery. Born in Montreal, Quebec, Canada, he first studied at the Séminaire de Sherbrooke where he obtained a Quebec College Diploma in 1978 followed by an MD at Université de Sherbrooke in 1982. Completing his residency in general surgery at McGill University in Montreal, during which time he did research studies on human lipolysis in sepsis, he then went to Paris, France to complete a fellowship in liver surgery and a second fellowship in pancreas and complex GI surgery at the Lahey Clinic in Massachusetts.

In 1990, Dr. Gagner accepted his first teaching appointment at the Université de Montréal School of Medicine as an assistant professor of surgery (Hotel-Dieu de Montreal), during which time he introduced his skills in laparoscopic surgery. As a pioneer of robotic assisted surgery, World first laparoscopic removal of the adrenal glands, the liver, bile duct and pancreas removal by laparoscopic surgery, he eventually made his way to the U.S. to practice at the Cleveland Clinic Foundation in Ohio where he co-founded the Minimally Invasive Surgery Center. He there, pioneered the use of endoscopic surgery for parathyroid and thyroid tumors in humans. He then became the director of the Minimally Invasive Surgery Center at Mount Sinai School of Medicine in New York, chair of the laparoscopic division and also earned the title of Franz Sichel Professor of Surgery. There he pioneered telesurgery with Professor Marescaux and Leroy of Strasbourg, the first trans-atlantic robotic assisted surgery, published in Nature in 2001. He then became head of the laparoscopic and bariatric surgery section at Cornell University's Weill Medical College (New York City).

Most recently serving as chief surgeon at Mount Sinai Hospital in Miami and professor of surgery at Florida International University, Dr. Gagner is now working out of the affiliated University of Montreal's Sacré-Coeur Hospital, as a professor of surgery and senior consultant. He also owns the Westmount Square Surgical Center, a private clinic specialized in bariatric surgery for weight loss and metabolic surgery for type-2 diabetes.

World-renowned for laparoscopic and bariatric surgery related to weight loss, the Clinic of Dr. Gagner, which is located in Montreal, specializes in the laparoscopic sleeve gastrectomy which he pioneered in 2000, as well as laparoscopic duodenal switch, which he was the first to perform in 1999, and various new innovative endoscopic treatments for obesity, type-2 diabetes, and gastro-intestinal tract disorders.

The author and co-author of more than 400 publications and 10 books, including the latest 2 on "Atlas of Hepato-Pancreatico-Biliary Surgery" and the "2nd Edition of Endocrine Surgery", Dr. Gagner is also a patentee in his field, especially on new methods to treat obesity and GI anastomosis. An elected fellow of the American College of Surgeons, the Royal College of Surgeons (Canada) and the American Society for Metabolic and Bariatric Surgery (ASMBS), he is also an honorary member of the Academie Nationale de Chirurgie de France, the Association Francaise de Chirurgie, the Mexican Laparoscopic Surgery Society, the Colombian Surgical Society, the Brazilian Surgical College, the Peruvian Surgical Society and the European Association for Endoscopic Surgery.

Dr. Gagner received a 2017 City of Marseille, France, Medal, SAGES Pioneer in Surgical Endoscopy Award (2017), 21rst Oliver H. Beahrs Professorship (Mayo Clinic 2016), Surgical innovation award from the ASMBS (2016), A2011 Excel Award by the Society of Laparoendoscopic Surgeons, a 2010–2011 French National Assembly Award, and Medal of the City of Bordeaux, Nice and Sete, France.

DR. ANDRE CROTTI AWARD FOR DISTINGUISHED SERVICE TO THE PROFESSION OF SURGERY RECIPIENT

Matthew Cooper, MD



Matthew Cooper is a Professor of Surgery at Georgetown School of Medicine, and Director of Kidney and Pancreas Transplantation and Director for Quality at the Medstar Georgetown Transplant Institute (MGTI).

After receiving his medical degree from the Georgetown University School of Medicine in 1994, Dr Cooper completed his general surgery training at the Medical College of Wisconsin followed by a fellowship in multi-organ abdominal transplantation in 2002 at the Johns Hopkins Hospital in Baltimore, MD.

He joined the transplant faculty at the Johns Hopkins Hospital upon completion of his training and was appointed Surgical Director of Kidney Transplantation and Clinical Research in 2003. Dr. Cooper joined the University of Maryland in 2005 directing the kidney transplant and clinical research program until 2012 following which he assumed his current role in Washington, DC.

Dr. Cooper seeks new opportunities for living donation through innovation and by removing the disincentives for those considering donation while promoting the safety and long-term care of live organ donors. His clinical interests included kidney and pancreas transplantation; particularly the use of marginal organs and has chaired both an NKF sponsored Task Force to decrease kidney allograft discards and a UNOS-sponsored System Performance Improvement Committee which have led to several exciting projects to potentially bring more patients an opportunity for transplantation. Dr. Cooper is involved in several ongoing clinical research projects primarily with an interest in immunosuppression minimization and amelioration of delayed graft function in kidney allografts following ischemic reperfusion injury. He has authored over 220 peer-reviewed manuscripts, 300 abstracts and 12 book chapters. He is regularly invited to speak on a variety of transplant-related topics both nationally and internationally.

Dr. Cooper is involved in transplantation activities both locally and on a national basis. He is the current UNOS/OPTN President. He is a member of the National and DC Board of Directors for the NKF and a member of the NKF's National Transplant Task Force. He has served as the chairman of the United Network of Organ Sharing (UNOS) Living Donor Committee and recently acted as the Councillor for UNOS' Region 2. He is a current councillor for the American Society of Transplant Surgeons. He is a current board member for the National Kidney Registry, the American Foundation for Donation and Transplantation, the International Pancreas and Islet Cell Transplant Association, and Donate Life America. Dr. Cooper has served as Chair of the American Transplant Congress.

And markets fill the streets with local shops, eateries and public artwork to enjoy. Come eat, drink, shop and explore what's new in downtown.





San Antonio's story begins with Spanish explorers. In 1691, they named the city in honor of Saint Anthony of Padua because they reached this new land on his feast day, June 13. In 1718, Franciscan priests and a military captain founded Mission San Antonio de Valero – the Alamo – to serve as a midpoint between the missions in northern Mexico and east Texas. At the same time, a presidio was established to protect them. Today, you can visit the Alamo – one of the city's five missions collectively designated as the first UNESCO World Heritage Site in Texas – and explore the Spanish Governor's Palace, a landmark that once provided housing for the captain of the presidio and served as headquarters for the soldiers stationed there.

Walk the downtown district by foot, rent a B Cycle, or step aboard a GO RIO river barge; for a narrative of the rich history of the city and the River Walk. Browse the eclectic collection at the Buckhorn Saloon & Museum, revisit tales of Texas History at the Briscoe Western Art Museum, or browse rotating exhibits at the Southwest School of Art. Catch a live theater production at the historic Majestic Theatre, Aztec Theatre, or the Tobin Center for the Performing Arts, then, grab a craft cocktail at the St. Anthony Hotel bar, Haunt, for an evening of glamour and unmatched hospitality. For free family fun, don't miss the 24-minute light show by French artist Xavier de Richemont, "San Antonio The Saga," on the exterior walls of the San Fernando Cathedral. For unique shopping, check out Shops at Rivercenter, or Market Square – three historic



blocks of shops and restaurants known as "El Mercado" or visit La Villita Historic Arts Village for a collection of shops and galleries offering local pop-up boutiques. For outdoor enthusiasts, Hemisfair – the home of Tower of the Americas and the Institute of Texan Cultures – boasts 37 acres of redeveloped urban park, including the Yanaguana Garden, playground, and surrounding eateries. Don't miss the Rainbow Crosswalk at the intersection of North Main Avenue and East Evergreen Street. In the downtown area, places to eat and drink are plentiful. Try Biga on the Banks for fine dining. For after-dinner fun, don't miss the bar at Bohanan's for classic cocktails and superior service, The Esquire Tavern on E. Commerce for casual drinks and snacks, and SoHo Wine & Martini Bar for karaoke and spirits.
